



Family Mediation Live Supervision Scheme

1. Trainee mediators who apply for live supervision should satisfy the requirements set out by HKMAAL (For details, please refer to “HKMAAL” requirements on ‘How to become a mediator – family mediator’ at www.hkmaal.org.hk)
2. The agency charges a standard rate of HK\$800 per hour for mediation supervision service. Supervision fee is capped at HK\$14,000 per live family mediation case.
3. Applicants are required to complete the “*Family Mediation Live Supervision Application Form*” attached and send to :

4. Upon receiving the application, the Centre Supervisor will assign an accredited supervisor (accredited by HKMAAL) for the eligible applicants.
5. Applicants will be replied by e-mail of the result of the application.
6. Final payment is due upon the termination of case, including drop-out cases and unsuccessful cases. The supervisor will complete the ‘Family Mediation Live Supervision Hour Record Sheet’ for endorsement by the supervisee.
7. All payment should be made by cheque and payable to “The Hong Kong Catholic Marriage Advisory Council”.
8. The agency provides only Cantonese speaking case for the practice.
